I fully accept all such risks of any injury, damage or loss regardless of severity that may be sustained and all responsibility for losses, costs and damages incurred in any and all activities connected with or associated with WisCorps.

By applying for The Gallery and signing this waiver and release form, I grant WisCorps permission to use, reuse, publish, and republish my name, business name (if applicable) and images of my Art and/or myself submitted by me or another individual to promote The Gallery. I understand that I am solely responsible for transporting, installing, selling, and removing my Art. I understand that at any time, without notice, WisCorps has the ability to exclude or remove any and all Art from The Gallery.
